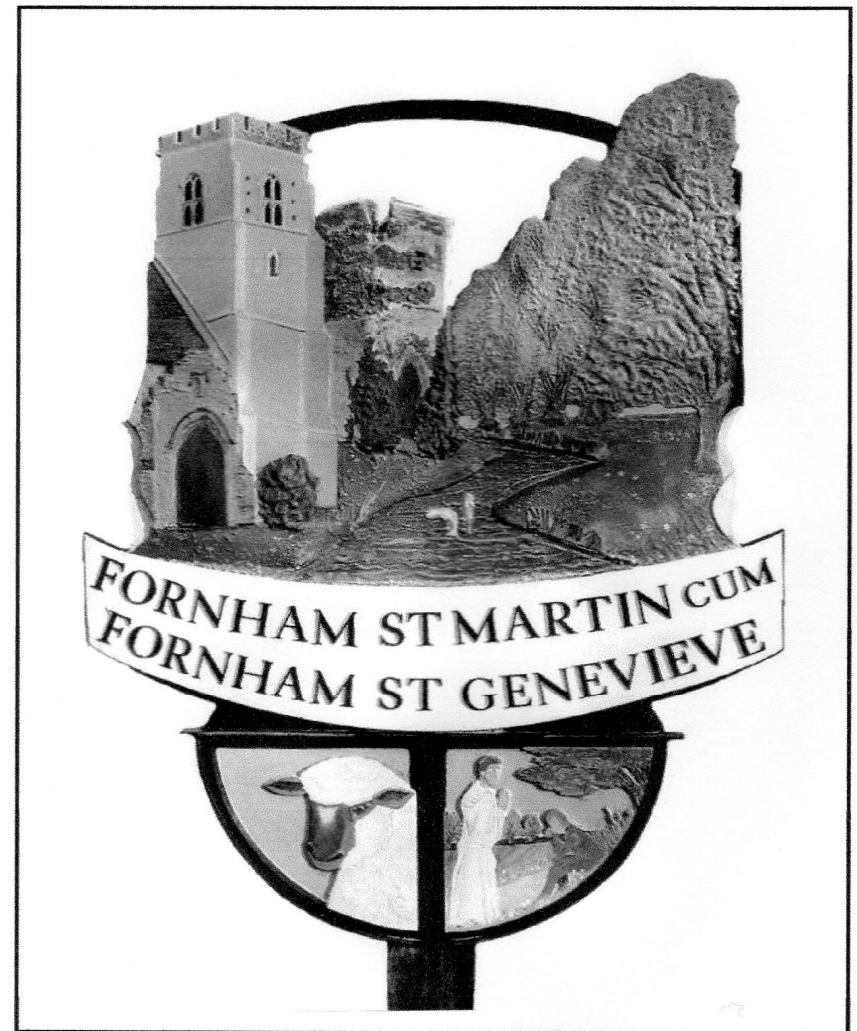
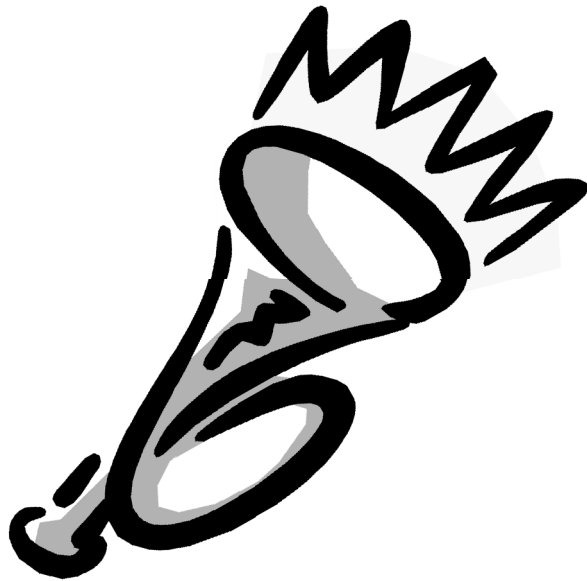

SUMMARY DRAFT SEPTEMBER 2022 Minutes of the Meeting of Fornham St Martin cum St Genevieve Parish Council

Councillors present: Cllr. J. Borrett - Chair (JBo), Cllr. M Collier - Vice Chair (MC), Cllr. P. Borrett (PBo), Cllr. P. Butler (PBu), Cllr. P. Forster (PF) & Cllr. S. Eley (SE)

Also present: Vicky Bright, Clerk, Cllr. Hopfensperger, WSC/SCC and 8 members of the public. Apologies: Cllr Frank Stennett.

Approval of the Minutes of the Parish Council Meeting held on 21st July 2022 -

The minutes of the Parish Council meeting held on 21st July 2022 were adopted as a true statement and signed by the Chairman (JBo).

Planning applications considered:

DC/22/1378/FUL - RETROSPECTIVE APPLICATION - outdoor gymnasium with open sided exercise shelter and moveable exercise equipment Location: All Saints Hotel, The Street, Fornham St Genevieve Resolved 22/09/6.01

It was agreed to object to retrospective application DC/22/1378/FUL with the following comments submitted to the LPA;

"Firstly, we would like to raise our concerns over the fact that the application is retrospective and bring attention to the applicants' blatant disregard for Planning Law. The lack of a planning application has meant that all the proper safeguards to protect wildlife, the environment, neighbours and any archaeology have been bypassed. In April 2021, following a site inspection by Planning Enforcement Officer, Andy Smith, it was noted that a request had been made to the owner to submit planning permission, albeit retrospectively, however it has taken another 16 months for this to be submitted.

The fact that the structure has already been built within St Johns Plantation, without the appropriate planning permission, within an ancient woodland that is protected by TPO 030(1960) W1 and TPO 003(1974) W1, shows the applicants complete disregard for the natural environment and historical and environmental value of the site. Paragraph 170 of the National Planning Policy Framework states:

Planning policies and decisions should contribute to and enhance the natural and local environment by: a) protecting and enhancing valued landscapes, sites of biodiversity or geological value and soils (in a manner commensurate with their statutory status or identified quality in the development plan). The application does not mention the loss of trees, it also states that there are no protected or priority species or important habitats on the site, however, it is impossible to know what was destroyed by the removal of the trees and subsequent building works as no ecology assessment was made prior to their destruction and construction of the gym. Concerns regarding the felling of the trees were raised in March 2021 and in April 2021; as the Parish Council we reported this to the local Enforcement Team to investigate and in April 2021 were advised that a site inspection had taken place, by Tree Officer Falcon Saunders, and it was noted that there had been a loss of trees and that land levels had changed which may be detrimental to the remaining trees in the area. It was stated that actions should be carried out to mitigate some of the damage that has already occurred by carrying out remedial works and replacement planting, along with replacement planting at a previous site where tree felling had taken place within the protected woodland (without permission), none of which has been carried out or enforced. Again, this highlights a historical disregard by the applicant for obtaining the correct permissions, adhering to planning/TPO law, adhering to enforcement recommendations and lack of concern for the local environment.

It is noted that there is a concrete "service track" within the woodland on the maps in the application; which is used by groundskeepers and presumably used during construction, this track also has no planning permission and again there is evidence of trees being felled for the construction of the track. Over the last two summers neighbours have been subjected to noise disturbance, starting as early as 6:45am most days, this incorporates loud shouting by instructors, music and repetitive noise from the use of a punch bag. Not to mention the noise endured by neighbours from heavy construction machinery during construction to fell trees, along with that was the pollution from bonfires regularly lit near neighbouring properties to dispose of the trees once felled. Residents have been historically complaining to the applicant and the gym staff regarding the noise, with no resolution to the issue being reached, and in fact with little effort from the applicant to resolve the issues being demonstrated. The noise of the instructors 'shouting encouragement' and counting 5,4,3,2,1 can be heard clearly by neighbours and as far away as

Lark Valley Drive end of Birkdale Court, some 300 metres away. The Parish Council have also raised the issue of noise disturbance to the applicant, again with no demonstration of any action to remediate the situation. Again, had planning permission been applied for before construction, the issue of noise pollution from the gym could have been addressed and conditions set to ensure this did not become a problem for residents. We would strongly recommend that if permission is granted, that conditions of approval be set to ensure the following; NO loud music, NO loudspeakers only headphones to be used, with opening hours 8am-5pm only, with NO Sundays or Bank Holidays.

Nearby neighbours are also being affected by early morning and evening light pollution, due to the lights used at the gym. Residents close by have reported light shining into their windows.

The application states 'No' under "Can the site be seen from a public road, public footpath, bridleway or other public land?" However, the gym structure can clearly be seen from 2 public rights of way paths across the golf course, as well as from a footpath leading from Park Avenue to St Andrews Drive.

The Parish Council would reiterate, that with the application being flawed with inaccurate information, the fact that it is retrospective and with the felling of TPO protected trees, along with the constant and distressing noise disturbance caused to residents, that we strongly object to the application and would strongly recommend refusal and immediate removal of the structure, along with enforcement to ensure the remedial works and replacement tree works be carried out forthwith."

Cllr. M. Collier declared an interest in this application and as such, did not take part in the discussion.

Update on Enforcement Ref: St Johns Plantation/Golf Course Trees & Outdoor Gym Building Ref: EN/21/0057

The Clerk advised that following the Tree Officers site inspection in April 2021, the hotel had been advised that 'remedial works and replacement planting to negate the impact of the loss of trees that has been identified at the site was needed, along with some replanting that had already been requested at another area of the site.' This works and replanting has never happened and despite many emails and follow ups, the Enforcement Team have failed to address the issue, with a recent response from Rachel Almond to Cllr, Hopfensperger stating.... *"The development comprises of a roofed structure and adjacent gym equipment. We understand it was installed as a response to government legislation during the pandemic which allowed for group fitness activity to be conducted outside. Government guidance at the time was to allow businesses to adapt to lockdown rules with minimal interference from Local Planning Authorities and to effectively tolerate short term breaches of planning rules. This was followed up by subsequent emergency amendments to the General Permitted Development Order and briefing notes from the Ministry of Housing, Levelling Up, Housing and Communities along the same lines. Similarly, the subsequent enforcement investigation that followed the original complaint about tree removal was conducted at a time where normal working practices were suspended and matters were delayed.*

Additionally, the two officers involved have now left the authority. I can see that the investigation was hindered by the pandemic and continuity that one would ordinarily expect.

Turning to the enforcement investigation, once the facts were established the enforcement team then had to consider whether it should instigate criminal proceedings in relation to unauthorised tree removal, whether any loss of trees would have been granted had consent been applied for and a need to regularise the development of the outside gym. The complaint was the clearance of an area of woodland TPO and the operational development as an outside gym. The latter is not in doubt and indeed the subject of the current application. The investigating officers confirmed that it was likely that trees had been removed and there was some evidence that land levels had been changed. An existing concrete pad had been extended and a road/track resurfaced. The unauthorised removal of such protected trees would constitute an offence. To pursue this through the courts would require the evidential and public interest test to be satisfied. From an evidential perspective the Council could prove the existence of the woodland TPO; as to what exact trees were or were not removed proved to be difficult to evidence beyond reasonable doubt, which is the test applied in the courts. From a public interest perspective, given the pandemic, government guidance on assisting businesses to adapt to Covid recovery and that the matter could be addressed through a subsequent planning application (which could include replacement planting), it was determined that criminal proceedings were not appropriate.".... ..

The Council expressed their frustration that the replanting scheme was not being enforced and that the applicant was being allowed to break the law with no consequence. Cllr. Hopfensperger is to go back and follow this up with Rachel Almond.

Update on Enforcement Ref: Petting Zoo/Field at bottom of Barton Hill Ref: EN/22/0105

The Clerk advised that Enforcement had investigated the site and the case has now been closed by WSC.

Update on Enforcement Ref: 21 Barton Hill Market Stall Ref: EN/22/0153

The Clerk advised that enforcement has investigated and the resident has been asked to remove the stall/tents.

Highways/Footpaths & Trees:

Update on Highways Outstanding Matters

- **Flooding BMW garage** – this has been added to the works schedule for this financial year (22/23); new gully’s will flow into carrier pipes (extra pipes to be added) into the ditch.
- **Russell Baron Road** – Still flooding!! We were told the drainage had been jetted in July 22, but the Chair has confirmed that this is not the case. Cllr Hopfensperger to follow up.
- **Barton Hill Flooding** – a kerb outlet not in operation has been identified and will be re-commissioned, the Chair advised that this has been filled back in! Cllr. Hopfensperger is to follow up.
- **The street licence application and Locality funding** - the application is to be filled out by the Clerk for the new entrance gate (FSG end) and new sign on The Street.
- **The 4 trees removed on the new footpath to the Hub** - the team have confirmed that they will be replaced.
- **The missing/damaged 30mph signs** - will be replaced

CHURCH NEWS

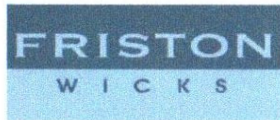

FORNHAM GARDEN CLUB – Catriona Smart

At our meeting in August we welcomed Simon White, General and Sales Manager of Beale's Roses in Attleborough (classicroses.co.uk). Simon has visited the Club on numerous occasions and this time his talk was on "Rose Growing Made Easy".

He began by giving a brief introduction to Beale's and rose production. The nursery stocks about 1100 varieties and produces over 250,000 plants per year, with 2 years' crop in the ground at any one time. The planting of the nursery crop begins in spring with 30,000 plants machine planted each day.

Planting distance: modern roses (18 inches – 2 ft), shrub roses (2-3 ft), climbers and ramblers (7-10 ft). Add bone meal or mycorrhizal fungal powder. Bare rooted plants must go in from end Nov-Mar; containerised plants at any time.

Planting depth: ensure the graft is at least one foot below soil level. With bare rooted plants, give a hard prune to 3-5 inches above ground at time of planting.

Water: water well at time of planting and throughout the year, particularly the first.

Feeding: Add granular feed around base of plant in Feb/Mar and again in July. Supplement with a liquid feed every 14 days in the growing season.

Pruning: prune hard in early spring, cutting out dead, diseased, damaged, and weak branches, removing all crossing branches to maintain an open structure similar to the shape of a wine glass. Bypass secateurs are best as they provide the cleanest cut. Prune at a 45 degree angle above a bud or straight across.

The annual Suffolk Historic Church's Trust, Ride and Stride on Saturday 10th September, went well, thanks to Judith and Simon Eley doing the riding around 13 country churches in all, and Heather Long striding around her 9 Bury churches. At present just over £400 has been raised in sponsorships, so thanks to everyone who supported them. On 1st October there is another of our Jams and Chutney Sales at the Gate, in the churchyard, with a very nice selection lovingly made by Beryl, Heather, Sarah and Sylvia, at present, with teas and probably a few cakes and scones available too. Then, we welcome the return of the Tudor Rose Singers on Saturday 29th October. They have performed in the church many times, and it will be nice to see them again, with their usual variety of light entertaining singing, to keyboard accompaniment.
